Call for Papers

Scholars in Italian studies are invited to reflect upon Italian literature and politics, as well as language and political discourse in its various dynamics and historical periods, from the origins of Italian literature to the present day.

Italian writers, poets and authors of treatises have always shown interest in the science and art of governing. They have analyzed politics in order to theorize it or, on a practical level, to support or denounce it. From literature emanating from certain centers of power, towards which it must fulfil a celebratory duty, to literature which embraces a role of denunciation and dissent in relation to regimes and ideologies, several types of ‘political literature’ can be distinguished. Points of reference within this complex topic are a literature that legitimizes politics, a disengaged literature written by intellectuals who isolate themselves from an unacceptable world, a polemical, protesting, subversive, or committed literature (Leonardo Sciascia, Pier Paolo Pasolini), a literature that theorizes politics (Niccolò Machiavelli, Francesco Guicciardini), memoirs and testimonies that reflect the dynamics of power (Silvio Pellico, Primo Levi, the literature of the Resistance) and their consequences on the fate of the individual.

Scholars are invited to submit wide-ranging essays questioning the relationship between literature and politics, the role of the former vis-à-vis the latter and vice versa; syntheses focusing on works reflecting the same ideology (e. g. Italian literature of socialist inspiration); reflections on the literary implications of the writer’s commitment or disengagement towards the problems of the State; essays on the dynamics and strategies of power reflected in literary texts, and punctual analyses on individual works or authors.

Possible, but not restricted, **topics** include:

- hypostasis of political power in literature from the 13th to the 16th century;
- political treatises in the 17th and 18th centuries;
- social, political, religious changes reflected in the works of the Enlightenment;
- political aspects in the early 19th century Italian novel;
- revolutions, wars and conflicts in literature; patriotic literature;
- theatre and politics: the political use of theatre;
- Italian literature during fascism, on fascism, during the “Anni di Piombo” (writers, essayists, magazines); literature of and about the Resistance;
- responsibility and political engagement of the writer; commitment and disengagement;
- ideologies and politics in Italian literature;
- praise literature and modes of praise;
- paratext and manipulation; politicization of literature;
- censorship and self-censorship;
- utopias and dystopias in Italian literature;
- politics and women’s literature; women of power in Italian literature;
- political and social aspects in current literature: the foreigner, migration, national identities, globalisation, *métissage*, political, cultural and social turmoil;
- editorial policies.

From a linguistic perspective, the conference will welcome original contributions of political discourse analysis from corpora of different historical periods, including contemporary ones. Any linguistic aspect, from political terminology to the pragmatics of media communication, in monologues or debates, may be subject to analysis.

The studies of Chilton (2003), Fairclough and Fairclough (2012), and the volume edited by Okulska and Cap (2010) are to be mentioned within the vast literature analyzing the multiple aspects of political communication. Clemenzi's recent study (2023), the volume edited by Librandi and Piro (2016), the perspective on the semantic vagueness of political discourse in Paternostro (2021), or McDonnell and Ondelli's (2020) approach to the terminology of populists are to be mentioned in the Italian context.

Possible **topics** include:

- critical analysis of political discourse;
- stylistics and pragmatics of political discourse;
- linguistic features of political discourse in the new media;
- terminology of political discourse;
- problems of translation and interpretation of politicians' speeches.
